CIRCULAR

All government/private medical colleges which have applied for the Renewal/Recognition/Continuation of Recognition of annual intake or increase intake of MBBS seats and also for PG course/seats for academic year 2020-21 via online portal or offline can take fresh batch through counselling for admitting the students for the academic year 2021-22. The same is applicable for:

- (a) those medical colleges whose inspection has either been done or not till date.
- (b) those medical colleges, whose application is either processed or not till date.

The status of the college & number of seats will remain same as it was during the academic year 2019-20. Also, the colleges who have either applied or not during the academic year 2020-21, are also eligible for taking fresh admissions for A.Y. 2021-22.


